- 5. Bids will be opened in the presence of Bidder's representatives who choose to attend in person at 2:00 P.M. on 2075/11/08 (20th February 2019) at the Office of Molung Rural Municipality, Prapcha, Okhaldhunga. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a Bid Security or a scanned copy of the bid security, amounting to a minimum amount as specified in the table above, which shall be valid for 30 days beyond the validity period of the bid.
- If bidder wishes to submit the Bid Security in the form of cash, bidder has to deposit cash in deposit account no. 0880515147703004 of office of Molung Rural Municipality at Sunrise Bank Ltd., Molung Branch and submit bank deposit voucher along with the bid.
- 7. Information or data submitted by the bidder which is either incomplete or unclear or not substantiated by supporting documents shall not be considered for evaluation.
- 8. Bidders are advised to visit site and assess the actual site conditions before submitting their bid.
- 9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 10. Other related rules & regulations are as per Public Procurement Act-2063 and Public Procurement Regulation-2064.
- 11. The employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
